Prof. Gabriel Weimann

Prof. Weimann is a Professor of Communication (Emeritus) at the Department of Communications, University of Haifa, Israel; and a Visiting Professor at the University of Maryland, USA.

His research areas include political campaigns, persuasion and influence, modern terrorism and the mass media, online terrorism and cyberterrorism. Prof. Weimann received numerous grants and awards from international foundations, including the Fulbright Foundation, the Canadian-Israel Foundation, the Alexander von Humboldt-Stiftung and others.

Prof. Weimann is currently a Senior Researcher at ICT.

Brig. Gen. Brig. Gen. Fox is currently on leave from the IDF and serves as a Visiting Fellow at ICT.




Dr. Moran Yarchi

New Research Desks



Terror and Economy

The Terror and Economy Desk deals with the impact of the global economy on global terrorism, as a basis for formulating additional ways of coping with threats of terrorism in the West.

The projects will deal with issues such as the terrorist organizations' use of the Islamic economy to promote terrorism; the effect of interest rate changes on the organizations' cash flows; use of virtual currencies and more.

Academic Taglit: Birthright

ICT hosted during 2018 two groups of "Birthright Study Abroad", an Academic "Conflict Management & Counter Terrorism" course specially designed to Taglit project.

The two groups included 25-35 students each, all of them 18-25 years old. The students got a 12 day journey, class lectures, field trips, as well as urban warfare and terror attacks simulations.





The RED-Alert project is a European Union's Horizon 2020 funded project, aimed to provide LEAs with a complete toolkit to detect, collect, analyse and store online data from social media channels, related to terrorism Led by a consortium comprised of tech companies, research centers and universities and LEAs, RED-ALERT will cover a wide range of social media channels and will allow LEAs to take real-time coordinated action while preserving the privacy of the citizens.



RED-Alert brings the best of European research and innovation experts together to fight terrorism with a consortium of 15 organizations including European law enforcement agencies, supported by academic institutions and technology companies.

The specific objectives of RED-Alert are:

Objective 1: Improve available building blocks (NLP, SNA, CEP) and combine them with artificial intelligence (AI) in order to support the language, usability and privacy-preserving requirements of the RED-Alert solution.

Objective 2: Integrate all building blocks (NLP, SNA, CEP) in a holistic solution with real-time collaborative capabilities and create a baseline system (development environment) for current and future use.


Objective 3: Involve law enforcement agencies in drafting the specifications and the building of the RED-Alert solution.

Objective 4: Disseminate the project results to the scientific and law enforcement communities, prepare the exploitation of the RED-Alert solution and its individual modules.

TRIVALENT is a Horizon 2020 EU funded project that aims to a better understanding of root causes of the phenomenon of violent radicalisation in Europe in order to develop appropriate countermeasures, ranging from early detection methodologies to techniques of counternarrative.

The Lone Wolf Project research jointly conducted by the ICT and the Israeli Ministry of Public Security, and led by Prof. Boaz Ganor and Prof. Ariel Merari. The project examined profile of independent the ("lone terrorists wolf") reflected in the recent wave of terror attacks. As part of the research methodology, the ICT conducted a series of interviews with 45 prisoners and created a database of 700 lone wolves.

The International Cyber-Terrorism Regulation Project (ICTRP) is being carried out with funding from the Global Internet Forum to Counter-Terrorism (GIFCT) through a global research network led by the Royal United Services Institute (RUSI), based in London. GIFCT is an industry-led initiative comprising Facebook, Google, Microsoft and Twitter and will publish a series of papers that aims to provide recommendations around the prevention of terrorist exploitation of technology to policymakers, technology companies and other stakeholders.

The project identifies and analyses regulatory models - laws, strategies, policies, and enforcement measures - for countering terrorists' use of the internet (including cyber-enabled acts of terrorism) through two initial products: a website that is both easily accessible and provides an in-depth presentation of the models studied; and a policy paper highlighting a set of recommendations for leveraging the lessons learned from these models, being prepared for publication by April 2019.

One of the key aims of the ICTRP is to eventually facilitate information exchange and cooperation among regulators who are dealing with this challenge in selected national and international jurisdictions; and among social media platforms that have initiated self-regulation with respect to hostile and illegal content. ICTRP's intended readership includes policymakers, lawmakers, researchers, and students in the field of counterterrorism.



Terrorists are increasingly leveraging their use of the internet across ten major categories of hostile activity: propaganda, psychological operations, incitement, recruitment, radicalization, financing, information sharing (including training), intelligence, communications, and cyberterrorism. At the same time, governments, international organizations, and private companies that provide social media platforms (SMPs) have been developing measures to fight such hostile uses of cyberspace in general, and the internet in particular, through the use of an increasingly diverse regulatory toolbox.

Such regulatory measures encompass the traditional modes of national laws, strategies, and policies. They also include international treaties and protocols; the resolutions, decisions and public declarations made by international organizations; and capacity-building initiatives for bolstering the enforcement of counterterrorism at the national and global levels. Although there are currently no overarching international treaties governing counter-terrorism efforts regarding terrorist use of the internet, several multilateral agreements and arrangements currently provide a normative basis for addressing some aspects thereof.

The International Homeland Security Forum





ICT's 18th Annual International Conference: World Summit on Counter-Terrorism



For past decades, the Lauder School of Government has been offering courses on terrorism, counter-terrorism and homeland security. These courses are taught by leading international scholars and Israeli security professionals from the ICT.

Prof. Boaz Ganor, Founder and Executive Director of the ICT and Dean of the Lauder School of Government, is the program's director.



Brig. Gen. (Res.) Nitzan Nuriel, Associate at ICT, IDC Herzliya

Brig. Gen. (Res.) Nitzan Nuriel previously served as the Director of the Counter-Terrorism Bureau at the National Security Council. He currently serves as the deputy Commander of the Depth Corps of the IDF. He has also served as the head of Israel-US International Exercise Directorate since 2003. In this framework, he is in charge of planning and managing the military exercises, including drawing conclusions.

Nuriel has served as an associate at the ICT for several years. In this framework, he took part in many of the ICT's events,

lectured in front of various audiences, participated in simulations, gave briefings to foreign guests and officials on a political and security level, and participated in many think-tanks in his field of expertise.



In his opinion, the greatest terrorism threat facing the world today is non-conventional terrorism as it is a very simple to produce. There are detailed explanations for preparation of these weapons on the internet and non-conventional material can be hidden inside any product, however small.

Nuriel's outlook on counter-terrorism consists of three central views that he believes will significantly improve the ability to protect the country's citizens, when implemented:

• Nuriel believes that the municipal level plays an important role in all things related to counter-terrorism. In his opinion, the mayor knows best what his district needs from a security standpoint. He should be given the option, for example, to decide for himself how to protect public places in the city, such as cafes. Therefore, we must begin to delegate more and more authority to the municipal level, rather than the federal level. In addition, in his opinion, a multi-casualty event should be practiced at a municipal level at least twice a year, something that is not done at all at this level.



Lt. Gen. (Ret.) Orit Adaro Associate at ICT, IDC Herzliya

Lt. Gen. (Ret.) Orit Adato served as Women's Corps officer of the 36th Division (Armor Division) in the Golan Heights during Operation Peace for Galilee. Adato has served as an ICT Associate for many years.



Israel must anounce publicly (before the start of the next round) that it will no longertolerate rocket fire into its territory. 


The withdrawal of the United States from the nuclear agreement is one part of a much more complex picture, one that includes Israel's attacks on Iranian targets in Syria and the exposure of the intelligence operation in Iran.

A differentiation should be made between the short/immediate-term and the long-term regional outcomes of the withdrawal from the nuclear agreement. A differentiation should also be made between the actions that the Iranians will take because of Trump's withdrawal from the agreement and the actions that might be carried out against Israel in retaliation for actions attributed to Israel that are being carried out in Syria against Iranian assets.




